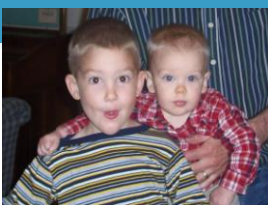

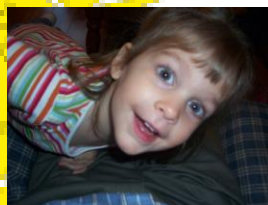
Purpose Statement
